RCOT welcomes that the Code of Practice is seeking to achieve a real change in how social services in Wales are measured and reported on and how the information gathered is used to inform the future of social services in Wales. RCOT data indicates that despite making up just 4% of the regulated workforce, occupational therapists address 35 – 45% of local authority referrals and therefore occupational therapists will have major contribution to efficient, effective and high quality social service functions in Wales

RCOT agree with the principles performance framework and the quality standards are a reasonable frame for setting ambition and articulating progress against the act. Our members are completing "what matters conversations" with citizens daily and are keen that the quality of those interactions and then the outcomes that follow are measured and are highlighted effectively

An increasing number of our occupational therapists are working in multi disciplinary and multi agency teams and with the future transformational elements of the Healthier Wales policy in moving health care into the community. We feel it is importance this is highlighted as more and more social services functions will be provided by integrated services that include Health Boards.

Quality standards are a reasonable frame for setting ambition and articulating progress against the act. RCOT recommends that the quality standards are designed in a way that will challenge local authorities, to learn, improve and develop care and support and deploy new innovative approaches to measurement to evidence their impact in relation to the Act.

RCOT welcomes the personalisation aspect of the quality standards. There is no doubt that people themselves are experts in what is important to them and that Care and support planning that embeds a shared approach to decision making recognises

that people bring different, and equally important, knowledge and expertise to the process.

ROCT have concerns around the measurement of Occupational Therapy within the technical guidance, the metrics focus on process and not on the quality of each interaction and how that could have a positive or negative effect on the citizen. The proposed framework has a focus on process and compliance rather than on what matters to people and the positive impact on their daily lives.

Social Care & Health is a complex system with many factors and associated interactions at play, it is too simplistic to attribute "cause and effect" to a single organisation, service, project . We are interested to see how this would be addressed in this work

Our members feel the technical guidance is extremely long and that the metrics tell them little other than volume, which will vary due to the nature of different local authorities and depending on the practices within. They don't believe the approach of measuring such a significant volume of metrics will allow them to measure the true expectations and impact of the Act within their areas.

This should focus on people's strengths, balancing choice and risk, maintaining people's occupations (daily activities) and connecting people to their community, family, carers and friends

Our members have concerns that the implementation timescales aren't achievable and realistic. They have stated that this would be a significant change not just in systems but in practice and may have an impact on services.

Comments:

Our members do not believe that it is easy to deploy a set of quantitative indicators to measure and compare the impact and effectiveness of the Integrated Service across local authority areas and health boards in wales, given there is significant variation between people and across all integrated services in Wales. For example, the Delayed Transfer of Care (DTOC) from hospital into the community is one measure of the average end to end time in days, and whether people are
