## Accreditation and ongoing accreditation

Use this 'go-to' resource to ensure your programme continues to meet the learning and development standards: Learning and development standards pre-registration education (2019).

You mustn't exceed the maximum number of accredited RCOT learner places. As the Professional or Progamme Lead it's your responsibility to <u>notify us</u> in advance if this is likely to change. RCOT and HCPC numbers may differ.

#### For each pre-registration programme to maintain accreditation we ask you to annually submit:

- Annual Monitoring Report which informs the Compiled Annual Monitoring Reports. This is due each January/February, for the previous academic year.
- Learner intake numbers based on the programme intake, this is due in either October or February.
- Graduate learner numbers. This is due at the end of the academic year.

In addition to the requirements above, apprenticeship programme providers must confirm they have met the requirements to join the register of End-Point Assessment (EPA) organisations before the first cohort reach the EPA gateway.

Our Learning and development standards for pre-registration education (2019) requires you to <u>let us know in advance of any changes to the programme</u> after it has been accredited. These updates feed into the accreditation and the annual monitoring process. You can do this using the <u>major change form</u>.

# **Annual touch points**

We'll request from you the information detailed above annually throughout the five-year accreditation period of your programmes. This is to ensure you evidence meeting the ongoing accreditation requirements.
